Of the world's largest public companies, Bongarde members include: Berkshire Hathaway (#4), Toyota Motor, Nestle, General Motors and more.

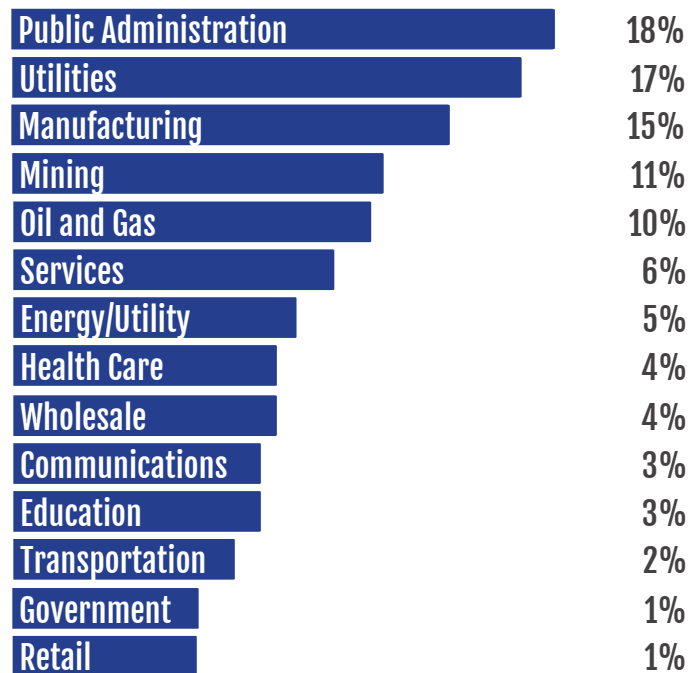


WHAT CAN YOU CONTRIBUTE?

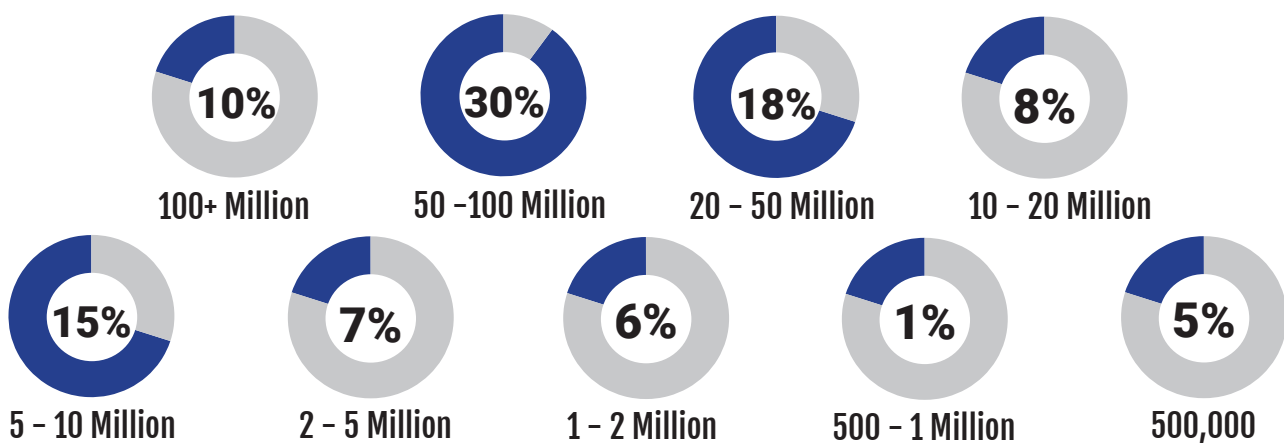
CIRCULATION
